#### IMMIGRATION PROGRAM CONTINUES TO GROW, BUT COMMUNITY NEED REMAINS VOLUNTEERS NEEDED!



Thanks to the efforts of immigration advocates, supportive legislators and the Governor, the New York State Office for New Americans substantially increased funding to immigration legal services providers across New York State, including to VLPCNY. VLPCNY's Upstate Immigration Pro Bono Project has volunteers serving immigrants in Central New York, the Mohawk Valley and North Country, and in collaboration with partner agencies also serves all of Western New York including Buffalo and Rochester. The Project will now begin serving the Capital Region as well. Sara McDowell, Esq. has been promoted to Deputy Executive Director for Immigration Programs and will offer critical leadership to our growing team as we provide legal assistance to immigrant and refugee communities. **"We are so thrilled to be able to expand our services to serve more immigration clients in Central New York and across New York State,"** said Sara McDowell, Deputy Executive Director for Immigration **legal services has far outweighed the availability of immigration legal service providers in recent years. ## **WELLNESS IN THE WORKPLACE**

Legal aid work can be overwhelming and stressful for all. VLPCNY has established a Wellness Committee that seeks to aid our team in caring for themselves and preventing burn out through providing interesting and relaxing experiences. Supported by a Health and Wellness Award graciously provided by **Excellus BlueCross BlueShield**, the team is working to identify ways that vicarious trauma affects wellbeing and our ability to advocate for racial and economic justice in our work. In June, our staff and interns used art to release tension and refocus on wellbeing by participating in a meditative painting workshop at the Liverpool Art Center.
